10 People Arrested and Charged with Various Firearms and Narcotics Offenses in Lower Windsor Township

York, PA – During the early morning hours of Thursday, June 1, 2023, police officers from Lower Windsor Township served a search warrant at 4735 East Prospect Road in Lower Windsor Township. This location is a three-story residence divided into two apartments and a small barn, which was used for social activities. Numerous persons were present in the residence when police arrived. The purpose of the warrant was to search for cocaine and firearms.

During the search, police officers located approximately 225 grams of cocaine, amounts of psilocybin mushroom, marijuana, related drug paraphernalia, and \$5,600 cash. Additionally, police officers located an Anderson Arms semi-automatic rifle, a Stevens shotgun, a 38-caliber revolver, a Glock 40 caliber handgun, a Ruger 9mm handgun, and ballistic body armor.

The investigation leading to the search of the residence focused on the cocaine distribution activities of Charles Lenhart. Police received several tips in the recent past pertaining to suspicious activity at the residence, including an unusual number of guests and cars arriving and departing from the residence.

Charged were Charles N. Lenhart III, age 43, possession of firearm prohibited, manufacture, deliver or possess with the intent to manufacture or deliver a controlled substance, knowingly or intentionally possessing a controlled substance (2 counts), use/possess drug paraphernalia, possession of a small amount of marijuana, prohibited offensive weapons, unlawful body armor, possess instruments of crime and criminal use of a communication facility; Jade D. Naylor, age 39, conspiracy – possession of firearm prohibited (3 counts), manufacture, deliver or possess with the intent to manufacture or deliver a controlled substance, conspiracy – possession of a small amount of marijuana, conspiracy – make repairs/sell/etc offensive weapons, conspiracy – unlawful body armor,

conspiracy, possession of instruments of crime, conspiracy – criminal use of a communication facility; Miquan R. Johnson, age 27, possession of firearm prohibited, manufacture, deliver or possess with the intent to manufacture or deliver a controlled substance, knowingly or intentionally possessing a controlled substance, use/possess drug paraphernalia, possession of a small amount of marijuana, false identification to law enforcement; Makayla M. Lenhart, age 22, conspiracy – possession of firearm prohibited, manufacture, deliver or possess with the intent to manufacture or deliver a controlled substance, knowingly or intentionally possession of firearm prohibited, manufacture, deliver or possess with the intent to manufacture or deliver a controlled substance, knowingly or intentionally possessing a controlled substance, use/possess drug paraphernalia, and possession of a small amount of marijuana. All four of the individuals mentioned above reside at 4735 East Prospect Rd.

Additionally, Brianna Bubb, age 26, was charged with knowingly or intentionally possessing a controlled substance and use/possess drug paraphernalia.

The following persons, all who reside at 4735 East Prospect Rd. were charged with misdemeanor use/possession of drug paraphernalia and marijunana-small amount personal use. Warrick Brown, age 24; Mariah Fleegle, age 22; Adriana Pangburn, age 19; Matthew Via, age 43; Stacy Walker, age 50.

York County District Attorney Dave Sunday commends the Lower Windsor Township Police Department for their diligence in this matter. "The District Attorney's Office will always work to provide necessary resources to York County police agencies in their efforts to remove guns and drugs from our streets. I thank all York County police officers for their daily efforts in combatting crime and working to keep our county safe," he said.

Also assisting with this investigation were the York County Drug Task Force, the York County Quick Response Team, the Hellam Township Police Department, and the York County Sheriff's Office.

Criminal charges, and any discussion thereof, are merely allegations and all defendants are presumed innocent until and unless proven guilty.
